

## Iniva's Fundraising Statement and Guidelines 2024

Iniva is committed to upholding high ethical standards in all fundraising activities to safeguard our reputation and support our mission of ***nurturing anti-racist and equitable spaces for artistic research, wellbeing, play, experimentation, and enjoyment with creatives and communities***. We will take reasonable due diligence of donors focusing to ensure compatibility with our mission, and our responsibility to develop and promote social and environmental justice.

### **Iniva's Fundraising Guidelines:**

Iniva will only accept financial or 'in kind' support from organisations, companies, or individuals who align with our mission and ethical standards. We will not knowingly accept support from entities engaged in any of the following practices, whether in the UK or abroad:

- Oppression of civil liberties and human rights.
- Activities significantly damaging to or destructive of the environment.
- Manufacture or supply of products or services unsuitable for children and young people, with a focus on those contributing to obesity problems.
- Production or supply of armaments or torture equipment.
- Manufacturing tobacco products or deriving more than 10% of their turnover from tobacco-related production.
- Manufacturing alcoholic beverages or deriving more than 10% of their turnover from alcohol-related production.
- Exploitation of child labour in the manufacture of products.
- Significant income derived from the production or distribution of pornography.

### **Political and Environmental Ethics:**

Iniva is dedicated to maintaining political neutrality and ensuring that our activities do not support or promote political parties or candidates. We will not accept donations from:

- Political parties or entities that significantly support them.
- Individuals or organisations known for their partisan political activities.
- Entities involved in lobbying activities that conflict with Iniva's mission and values.

Iniva also prioritises environmental sustainability and responsibility. We will not accept support from entities engaged in:

- Significant environmental pollution or degradation.
- Non-compliance with environmental regulations and standards.
- Practices that contribute to climate change without substantial mitigation efforts.

- Activities leading to deforestation, loss of biodiversity, or destruction of natural habitats.
- Production or trade of fossil fuels without a clear, committed transition towards renewable energy sources.
- Unsustainable agricultural or manufacturing practices that severely impact ecosystems.

**Fundraising Due Diligence:**

Iniva will undertake reasonable due diligence of donors to ensure they do not hold views or engage in activities that are incompatible with our role and could damage our reputation. We will assess the safety and compatibility of accepting any gift and ensure that doing so is in the best interests of our charity. Additionally, we will consider issues such as suspicious donations, managing large anonymous gifts, and donations from vulnerable individuals.

**Compliance and Review:**

All fundraising activities will be conducted in compliance with this Fundraising Policy and our due diligence procedures. Regular reviews will be conducted to ensure alignment with our ethical standards, mission, and fundraising due diligence practices. Any donors found to be in violation of this policy or our due diligence standards will be ineligible for support.
